# Payment, Cancellation and Refund Policies Statement of Credits New Jersey Biennial Pharmacy License

#### Payment and Registration Payment is due upon registering.

Unless otherwise stated in the individual program description, the following applies to all programs!

Single Day Program: \$170 and \$185 (includes continental breakfast, lunch, break and booklet)

Half-Day Program: \$100 (am includes breakfast, break and booklet)

#### **New Jersey Biennial Pharmacy License Renewal Requirements**

Minimum of 30 credits of which at least 10 must be obtained through didactic instruction (in-person, telephone or electronic instruction; but does not include video-taped instruction) and 3 credits shall be obtained in pharmacy law applicable to pharmacy practice in New Jersey.

Ten credits of continuing education may be carried over into succeeding biennial period only if such credits were earned during the last six months of the preceding biennial period and were not previously reported.
