

When women lose their health benefits, they often neglect themselves and don't seek out the care they need at such a vulnerable time of life. The ability to securely and quickly share vital health information can help patients avoid re-admissions, medication errors, and duplicate tests — and can lead to improved diagnoses. In New Jersey, the statewide health information network is called the <u>NJHIN</u> and it's run by the <u>Department of Health</u> with support from **our member**, the <u>New Jersey Innovation Institute (NJII)</u>.

The greater the participation in the network from health care providers, hospitals, and insurers the more effective the network will be for patients.
