First-in-the-Nation Mental Health First Aid Training Customized for Perinatal Community Health Care Workers

At the Quality Institute, several of our staff members are trained trainers in Mental Health First Aid (MHFA), which is sometimes dubbed "CPR for mental health." We've been training people throughout the state to recognize and help those experiencing a mental health crisis. Attendees range from police and fire officials to teachers, school staff, and local volunteers.

Through our trainings as well as our work in maternal infant health, and after reading the recently published **NJ Maternal Mortality Report**, we were motivated to customize a MHFA training for perinatal community health workers, who support pregnant people during the prenatal, delivery, and postpartum period. We are grateful to **The Health Care Foundation of New Jersey**, which shared our vision and is now supporting our efforts to provide these trainings and to create and pilot the first-inthe-nation customized MHFA scenarios for perinatal community health workers.

The need is urgent. The NJ Maternal Mortality Review Committee found that the leading underlying cause of pregnancy-associated deaths is mental health conditions. Leading contributing factors include mental health complications and lack of care coordination, provider-patient knowledge, and a lack of standardized policies and procedures. The Committee also determined that nearly all these deaths were preventable. That is why it is so critical to provide MHFA training to the community health workers and others who are in closest contact and who are trusted by the pregnant person. With this training, they'll be better equipped to recognize signs of mental health distress and steer their clients to the help they

Roy Leitstein, MS, is the CEO of Legacy Treatment Services, a New Jersey-based nonprofit behavioral health and social services provider. Leitstein will speak at the **Quality Institute's Spring All-Council Conference on May 17**.

<u>Interview Sneak Peek:</u> How do the continuing barriers to integrating physical and mental health care harm patients?

Quite simply, if patients don't feel like the environment is one that's conducive to discussing their mental health or addiction challenges, then they won't discuss it. In those circumstances, we piecemeal behavioral health care treatment.

We need integration of care. We know that a substantial portion of psychotropic medication is prescribed by individuals who do not have an expertise in behavioral health and mental health or addiction treatment. So, when you go to a primary care doc — or I use the example of an OBGYN who prescribes an antidepressant for postpartum depression — the patient is missing a significant component of treatment, especially if the initial pharmacological intervention isn't successful...
