About the NJHC:

The North Jersey Health Collaborative (NJHC) is an independent 501(c)(3) organization that aims to improve the health of our communities that make up Morris, Passaic, Sussex, Union, and Warren Counties. With a diverse set of over 150 partners in healthcare, public health, social services, education, community-based organizations, local coalitions, and residents, the NJHC works to identify the most pressing needs and facilitate the development of collaborative strategies to address them. The NJHC's mission is to build capacity to improve community health using the most up-to-date public health data available to build networks across sectors; inform and develop Community Health Needs Assessments and Community Health Improvement Plans; and to provide a shared framework to leverage resources and demonstrate the work of our partners through the evidence-based, collective impact model (Kanie & Kramer, 2011).

Partners across sectors meet quarterly to engage in discussions on all things health promotion and public health, along-side local government agencies, non-profits, and businesses who provide resources, programs, and services in their communities.

Open 2024 Executive Committee Positions:

President: Public-facing position, leads Executive Committee meetings and Board of Trustee Meetings (1 year), then acts as an advisor (1 year).

Vice President, President Elect: Observes the duties of the president and assists when needed, transitions into Presidential position after 1 year.

Secretary: Responsible for keeping minutes of all Board of Trustee and Executive Committee Meetings (2 years).

Treasurer: Responsible for timely tax returns, annual corporation filings, and provides quarterly report of NJHC moneys, funding, and expenses (2 years).
