PRESIDENT & CEO, LINDA SCHWIMMER Winter Conference: Innovation and Planning Needed as New Jersey's Population Ages

In New Jersey, more than 1.5 million people are over the age of 65, or about 17 percent of our population. The percentage is expected to continue rising. Most people in this age group want to stay in their communities as they get older — close to families, friends, and other connections in their lives. An AARP poll shows that eight in 10 New Jersey voters would prefer being cared for at home if they ever need help. Yet enabling people to age in place will require fundamental shifts in our towns and cities, everything from transportation to housing to the health care workforce.

Our Quality Institute members repeatedly tell us that supporting New Jersey's aging population is a priority for them. That's why our Winter Conference this year will be, "A Framework for an Age Friendly New Jersey." I urge you all to join us on December 12. Interview Sneak Peek: As an economist, what demographic shift in the next 30 years will be most significant?

Birth rates are falling, and people are living longer. That's happening all around the world. The combination means that countries are aging — and if they are not now, they will be very soon.

Globally, one in four adults is over 50. By 2050, the number would be one in three. The shift in the United States is more pronounced. In 2020, about 36% of the population in the United States is over 50. In 30 years, the percent will be around 40 percent. It really is something to celebrate because we've made gains that enable people in the United States and around the world to live longer lives. But it also means that we need to rethink work, how we live, how we interact with others. Everything's got to change...

PEREZ-HUDGINS APPOINTED TO PQM COMMITTEE

Critical Voice on Measure Endorsement

Adelisa Perez-Hudgins, MSN, RN, the Quality Institute's Director of Quality,

The Quality Institute has been an active part of the measure review and

has been appointed to the Partnership for Quality Measurement (PQM), led by Battelle. The partnership is now the CMS contracted organization to review and endorse measures for use in CMS programs. PQM uses a consensus-based process involving clinicians, patients, measure experts, and health information technology specialists to ensure informed and thoughtful endorsement reviews of qualified measures.

Perez-Hudgins, MSN, RN, was appointed to the Primary and Prevention Committee, which will consider measures that address preventive care, education and counseling, health promotion, and screening measures. Subtopics may include health-related lifestyle behaviors, observable risk factors (e.g., age, obesity), and vaccination. Additionally, measures that address mental health screenings (e.g., depression, other psychiatric conditions), alcohol and drug use, comorbidities, and suicide risk screening are also included in their purview.
